5. Quotations must be valid for a period of 75 days after opening of tender quotations and must be accompanied by Cash Security or Bank Guarantee, amounting to a minimum of *amount as specified in table above*, which shall be valid for 75 days after opening of the Tender Quotations.
6. If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No.: No.9541498687524004 NIC Asia bank Bauniya Branch Kailali. and submit the receipt of the deposited amount of cash along with the Tender Quotation.
7. Tender Quotations shall be opened in the presence of Suppliers' representatives who choose to attend at 2 PM on 2075/02/11 at the Bardagauriya Rural Municipality, Muda Kailali
8. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day.
9. If bidders are not manufacturer, they must submit sole authorization letter from the manufacturer or from the authorized distributor of the manufacturer.
